



## **SPECIAL CONDITIONS OF TAKING PART IN ARCHERY SESSIONS AT CAXTON HOUSE COMMUNITY CENTRE.**

### **Pandemic Safety Measures and Liability Waiver.**

Please read this document in its entirety and sign and date the final page. Please email it back to us before your session. Failure to do so will mean that you will not be able to take part in the session (If you have any problem doing this please contact us before the session and we can arrange for you to sign it on arrival).

I (and or the Parent or Guardian on behalf of a child) understands that the novel coronavirus (COVID-19) has been declared by the World Health Organisation as a worldwide pandemic and is extremely contagious. It is believed to be spread by person-to-person contact and also by contact with contaminated surfaces.

As a result, social distancing is recommended and surfaces that a person may come into contact will have to be regularly decontaminated. Experience Archery and or Caxton House Community Centre cannot entirely guaranteed this, however, we are satisfied that the safety and cleaning measures that are in place at the venue and during our sessions will minimise the risk as much as possible, and contact will be kept to an absolute minimum in line with safety needs.

Please note:

- The space where the archery takes place and all the equipment involved in running the session will be cleaned before your arrival and after you leave.
- Our sessions will have a limited number of people in each session with social distancing and specific distanced seating in place in order that social distancing can be maintained. Please ensure that when you attend that you maintain social distancing while waiting to enter the premises, observe the one-way system within the premises (where applicable), and as far as possible when using more confined areas e.g. moving past other people that this should be kept as brief as possible and with 1m spacing where possible. We ask that people only use the toilets where absolutely necessary and only one person may use the toilets at a time.
- A face mask is required for entering and exiting the building and while in communal areas outside of the space that the archery is taking place in. Use of a facemask and or gloves while actively shooting is optional, please use provided hand sanitiser on arrival at the venue.
- You will be responsible for the disposal of your own rubbish while partaking in the session, including tissues any cleaning cloths, or drink containers. We ask that you dispose of these items off site or use the bins provided in the venue if absolutely necessary.
- There will be no food/drink available at the venue and we ask you not to bring any into the venue other than a bottle of water.
- We will have the right to close the session if there are safety concerns relating to COVID-19, for example, if someone who has attended the venue develops symptoms and thorough cleansing is required, or in the event that public buildings are asked or required to close again. If this is necessary, we will do our best to inform you promptly and you will be offered a voucher valid for 12 months to take part in a session at a later date.
- In the event that yourself or someone in your party becoming unwell with suspected Covid-19 symptoms while at the centre you should Call 111.



By signing this document I understand that Experience Archery and Caxton House are closely monitoring the COVID-19 situation and have put in place reasonable preventative measures aimed to reduce the spread of COVID-19. However, given the nature of the virus, I understand there is an inherent risk of becoming infected with COVID-19 by virtue of proceeding with this activity. I hereby acknowledge and assume the risk of becoming infected with COVID-19 through this elective pursuit, and I give my express permission to proceed.

I understand the COVID-19 virus has a long incubation period during which carriers of the virus may not show symptoms but could still be contagious. I understand that COVID-19 can cause additional health risks, some of which may not currently be known at this time. I understand all the potential risks, including but not limited to the potential short-term and long-term complications related to COVID-19, and I would like to proceed with my session.

I understand that air travel or attending events significantly increases my risk of contracting/transmitting the COVID-19 virus. I confirm that I have not travelled internationally within the last 14 days from a country where the Foreign and Commonwealth Office have listed it as posing an unacceptably high risk or where I am expected to quarantine on return and or attended any large scale event in the past 14 days.

I declare that I am not at risk or subject to shielding due to a medical/surgical condition.

I confirm that I am fit and healthy and able to take part in an archery session which may involve some strenuous activity and that if I have any worries I will consult a medical practitioner before taking part in the activity.

By taking part in the session I acknowledge that Experience Archery will keep a register of my attendance.

I confirm that I am happy for my temperature to be taken with an Infrared Non-Contact Forehead Thermometer, and that if a high reading is given or I fail to have my temperature taken that I will not be able to take part in the activity (If a higher than normal reading is given then you will have the opportunity to be retested 5 minutes later, if you still have a higher than normal temperature then unfortunately you will be asked to leave the venue).

I confirm that I have not had contact with anyone with COVID-19 symptoms in the past 14 days (whether through personal knowledge or through track and trace teams) or if my work involved caring for people who have the symptoms, I was wearing appropriate PPE.

I confirm that if I develop COVID-19 symptoms following my session or a known contact of mine develops symptoms, I will immediately inform Experience Archery and or Caxton House Community Centre to enable appropriate measures to be put in place and NHS guidelines of contact tracing to commence.

- I have chosen to attend the archery session provided by Experience Archery at Caxton House Community Centre and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while in the centre.

**I confirm that:**

- I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have not travelled internationally within the last 14 days from a country where the Foreign and Commonwealth Office have listed it as posing an unacceptably high risk, have advised against non-essential travel to that country and/or where quarantine restrictions are in force in that country.
- I have not visited an impacted area within the UK in the last 14 days.
- I do not believe they I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I have not been diagnosed with Coronavirus/Covid-19 and or not yet been cleared as non-contagious by public health authorities.
- I am following all government guidelines as much as possible and I am limiting my exposure to the Coronavirus/COVID-19.
